

**RESOLUTION NO. 2018-138
LOWER BRULE SIOUX TRIBE**

**APPROVE RESOLUTION ADOPTING RECOMMENDATION OF
ELECTION BOARD FOR CLARIFICATION OF JUDICIAL
QUALIFICATION JOB DESCRIPTION-CHIEF JUDGE POSITION**

WHEREAS, the Lower Brule Sioux Tribe is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of 1934; and

WHEREAS, as empowered by the Constitution and Bylaws, Article VI, Section 1, (e) the Tribal Council as authorized by law to safeguard and promote the peace, safety, morals, and general welfare of the Lower Brule Sioux Tribe and to regulate and conduct of trade and the use and disposition of property upon the reservation provided that any ordinance directly affecting nonmembers of the reservation shall be subject to review by the Secretary of the Interior; and

WHEREAS, the Lower Brule Sioux Tribe by and through Resolution 06-134 approved a Job Description to qualify for the position of Judge; and

WHEREAS, the Election Board unanimously passed a recommendation to the Lower Brule Sioux Tribal Council to adopt a clarification or change to the previously adopted Job Description for the position of Chief Judge; and

WHEREAS, the recommended clarification or change to the Lower Brule Sioux Tribal Council is that Section 4.5 of the Chief Judge Job description be amended to read, "4.5 Must be licensed to practice law and a member in good standing with the State Bar of South Dakota."

WHEREAS, you must submit the proof of qualifications in writing and proof of good standing with the State Bar of South Dakota with your petition at the time you turn it into the Election Board; and


NOW THEREFORE BE RESOLVED, that the Lower Brule Sioux Tribal Council does hereby formally adopts the recommendation of the Election Board concerning the Chief Judge Job Description; and

BE IT FURTHER RESOLVED, that the Lower Brule Sioux Tribal Council hereby formally adopts and changes Section 4.5 of the Chief Judge Job Description to read "4.5 Must be licensed to practice law and a member in good standing with the State Bar of South Dakota."

BE IT FURTHER RESOLVED, you must submit the proof of qualifications in writing and proof of good standing with the State Bar of South Dakota with your petition at the time you turn it into the Election Board.
